Applications are invited till 4 PM of 24th April, 2024 in prescribed format for filling up of 1 (One) post of Deputy Chief Legal Aid Defense Counsel at the fixed monthly honorarium/Salary of Rs. 40,000/- for the Court of Chief Judicial Magistrate, East Kameng District, Seppa purely on contractual basis under Legal Aid Defense Counsel Scheme, 2022 (Modified Scheme 2022) under the jurisdiction of the District & Sessions Court, Bomdila Sessions Division, West Kameng District, Arunachal Pradesh. The date of WALK-IN-INTERVIEW is tentatively fixed on 26.04.2024 at 02:00 PM (onwards).

1. ELIGIBILITY CRITERIA FOR DEPUTY LEGAL AID DEFENSE COUNSEL:-

A. Eligibility Criteria:

- i) Practice in Criminal law for at least 7 years.
- ii) Excellent oral and written communication skills.
- iii) Excellent understanding of Criminal law.
- iv) Skill in legal research,
- v) Thorough understanding of ethical duties of a defense counsel.
- vi) Ability to work effectively and efficiently with others.
- vii) Must have handled at least 20 criminal trials in Sessions Courts, may be relaxed in exceptional circumstances, by Hon'ble Executive Chairman, SLSA.
- viii) IT Knowledge with proficiency in work.
- ix) Applicant cannot take any private case or any other retainership after being engaged.

2. HOW TO APPLY?

- a) Candidates are to fill up in the prescribed "Application Form" enclosed with this advertisement.
